WHO wants to rule the world

Forced injections, vaccine passports, lockdowns and no scrutiny

THROUGH a series of 307 amendments and a pandemic preparedness treaty, the World Health Organisation is seeking to gain authority over the health decisions of all nations on Earth.

These powers would be triggered in the event of another covid-like 'pandemic'.

The WHO would be empowered to tell countries to lock down and close businesses, schools, pubs and churches.

We would be forced to take an injection, whether we want to or not. We would be forced to mask. We would be forced to do whatever it is that they tell us we have to do.

We have never before seen this level of authority given to an international, unelected body.

Those supporting this authority for the WHO say that it is necessary to protect the world's population, even if it means restricting some of our liberties.

Dr Abdullah Assiri, who co-chairs the Working Group on International Health Regulations (WGIHR), said: "The world requires a different level of legal mandates, such as the pandemic treaty, to navigate through a particular pandemic, should one occur, *and it will*."

"Prioritising actions that may restrict individual liberties, mandating and sharing of information, knowledge and resources - pandemic control efforts, are all necessary during a pandemic."

Dechen Wangmo, Bhutan's Health Minister agreed: "Let us seize this opportunity to



foster international collaboration, ensure global health security and protect the lives and the well-being of all people beyond boundaries."

And top backers of this United Nations move say speed is of the essence.

U.S. Secretary of Health and Human Services, Xavier Becerra, conveyed the urgency: "I wish to stress from our perspective, the quicker we can come together, the sooner we will all be safe."

"We know that the challenges we face won't be solved by a few leaders or a few countries, but by the world coming together and fighting for what's right."

In the UK, only a handful of MPs have voiced opposition to such undemocratic moves, despite overwhelming public opposition.

The UN is being underhanded by not calling this a treaty, which would require Parliamentary scrutiny, but rather an 'accord' - so there is no debate about the fact that an unaccountable, supra-governmental organisation will be able to order businesses shut and people injected with dangerous products against their will.

This would form a serious constitutional crisis on the nature of people's freedom. Supporters of the WHO and this planned

'accord' say critics worry too much, and that nations won't really lose sovereignty, but it remains to be seen just how powerful the WHO, which started as an advisory body, would become, if these new emergency powers are granted.

Further, the WGIHR has announced it will not be able to meet the deadline to submit its final draft by January 2024.

Instead of doing the honourable thing by admitting its failure and postponing the consideration of the amendments until the 78th World Health Assembly in 2025, it is plotting to violate the deadline imposed upon its actions by Article 55 of the IHR.

This Article states that it must submit a 'package of targeted amendments' at least four months in advance of the 77th World Health Assembly, which is scheduled to be held between May 27 and June 1, 2024.

This means the WGIHR is legally required to submit its final negotiated agreement by the week of January 22-26, 2024, otherwise it will need to wait until 2025.

The four-month period for review of the amendments is mandatory - the language of Article 55 is very clear - but the WGIHR is not planning to release the final text until the first day of the Assembly in 2024.

Medical crisis declaration

Warning of sudden deaths from covid injections

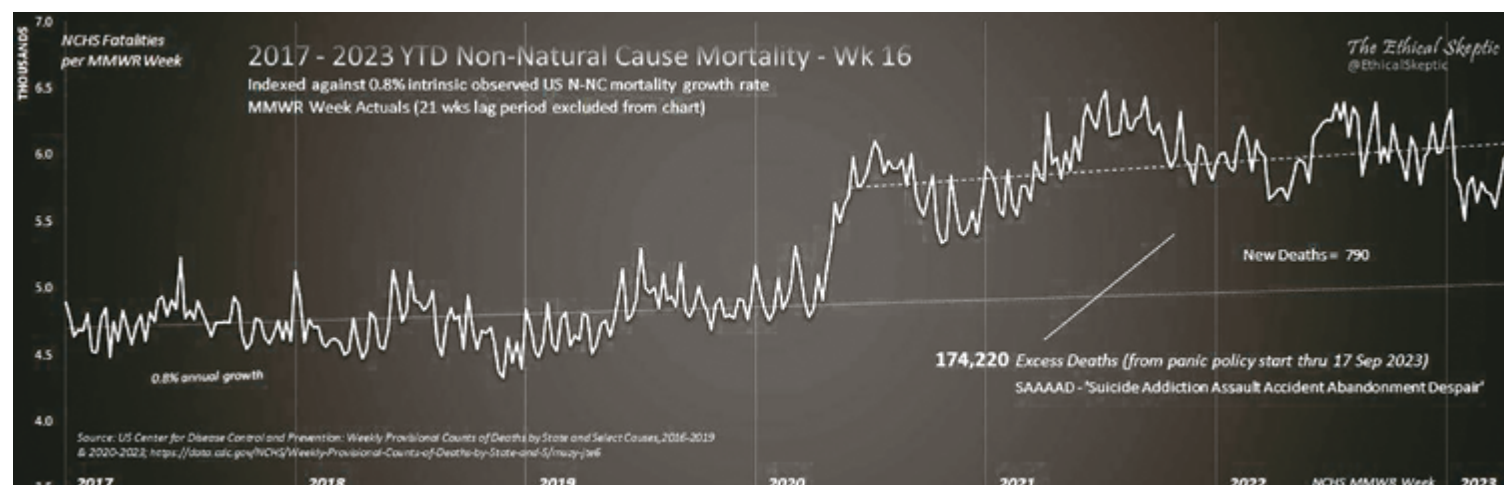
MORE than 400 doctors, scientists and professionals from 34 countries have declared an international medical crisis due to illnesses and deaths caused by the covid-19 injection.

The full declaration reads:

Declaration of international medical crisis due to the diseases and deaths co-related to the 'covid-19 vaccines'.

We, the medical doctors and scientists from all over the world, declare that there is an international medical crisis due to the diseases and deaths co-related to the administration of products known as 'covid-19 vaccines'.

We are currently witnessing an excess in mortality in those countries where the majority of the population has received the so-called 'covid-19 vaccines'. To date, this excess mortality has neither been sufficiently investigated nor studied by national and international health institutions.



This graph from @EthicalSkeptic shows that from March 2020 to Sept 2023, there were on average 790 excess deaths per week in the U.S., totalling a staggering 174,220 over that period.

The large number of sudden deaths in previously healthy young people who were inoculated with these 'vaccines', is particularly worrying, as is the high incidence of miscarriages and perinatal deaths which have not been investigated.

A large number of adverse side effects, including hospitalisations, permanent

disabilities and deaths related to the so-called 'covid-19 vaccines', have been reported officially.

The registered number has no precedent in world vaccination history.

Examining the reports on CDC's VAERS, the UK's Yellow Card System, the Australian Adverse Event Monitoring System, Europe's EudraVigilance System and the WHO's VigiAccess Database, to date there have been more than **11 million reports of adverse effects and more than 70,000 deaths** co-related to the inoculation of the products known as 'covid vaccines'.

We know that these numbers just about represent between 1 and 10 per cent of all real events.

Therefore, we consider that we are facing a serious international medical crisis, which must be accepted and treated as critical by all states, health institutions and medical personnel worldwide.

Therefore, the following measures must be undertaken on an urgent basis:

1. A worldwide stop to the national inoculation campaigns with the products known as 'covid-19 vaccines'.
2. Investigation of all sudden deaths of people who were healthy previous to the inoculation.
3. Implementation of early detection programmes of cardiovascular events which could lead to sudden deaths with analysis such as D-dimer and Troponin, in all those that were inoculated with the products known as 'covid-19 vaccines', as well as the early detection of serious tumours.
4. Implementation of research and treatment programmes for victims of adverse effects after receiving the so-

called 'covid-19 vaccine'.

5. Undertaking analyses of the composition of vials of Pfizer, Moderna, AstraZeneca, Janssen, Sinovac, Sputnik V and any other products known as 'covid-19 vaccines', by independent research groups with no affiliation to pharmaceutical companies, nor any conflict of interest.
6. Studies to be conducted on the interactions between the different components of the so-called 'covid-19 vaccines' and their molecular, cellular and biological effects.
7. Implementation of psychological help and compensation programmes for any person that has developed a disease or disability as a consequence of the so-called 'covid-19 vaccines'.
8. Implementation and promotion of psychological help and compensation programmes for the family members of any person who died as a result of having been inoculated with the product known as 'covid-19 vaccines'.

We declare that we find ourselves in an unprecedented international medical crisis in the history of medicine, due to the large number of diseases and deaths associated with the 'vaccines against covid-19'.

Therefore, we demand that the regulatory agencies that oversee drug safety as well as the health institutions in all countries, together with the international institutions such as the WHO, PHO, EMA, FDA, UK-MHRA and NIH respond to this declaration and act in accordance with the eight measures demanded in this manifesto.

Wars also distract us from the real agenda of total control

'WE need a new approach to digital identity,' so say the authors of an 'Agenda Article' for the World Economic Forum, published on September 28.

Digital ID has been in the news a lot lately, obscured for a time in the midst of the Israel situation.

Last month, the United Nations Development Programme published its legal guidelines for digital IDs as well as 'mobilising' global leadership with a \$400m fund to empower digital identity programmes in over 100 countries.

Various nations are already taking steps in that direction. Multiple U.S. states are either already issuing digital IDs or planning to in the near future, as are Kenya, Somalia, Bhutan and Singapore. Austria's system is going online in December.

Just last week, Forbes Australia published its guide to what 'Australians need to know about digital IDs,' and 9News reported that they could be in place as soon as next year.

Just two days ago, the Journal of Australian Law Society predicted the same thing.

Meanwhile, also in Australia, the world's 21st largest bank is changing its terms and conditions to allow it to 'debank' customers.

The National Australian Bank's revised terms and conditions were due to go into force on November 1 and include, in clause 11: 'NAB may close your account at any time at its discretion.'

The reasons NAB would consider enforcing clause 11 make for interesting reading.

NAB can take a range of things into account when exercising its rights and discretions. These can include:

- NAB's public statements, including those relating to protecting vulnerable persons, the environment or sustainability;
- community expectations and any impact on NAB's reputation.

So - as of November 1 - NAB reserves the right to debank you if you get cancelled, or say something they don't approve of about climate change or 'vulnerable people'.

In the UK, it was reported that the

government is planning to upload every passport photo in their records to a facial recognition database.

Big Brother Watch reports: 'At the same time, despite 'record profits' for energy companies last winter, the UK government reports they may need to further increase energy bills to "prevent energy companies going bust".'

Japan has announced it would be trading carbon credits on its stock exchange, and some Japanese firms are introducing a digital currency specifically for the settlement of 'clean energy certificates'.

Meanwhile, India has revealed the launch of trial wholesale digital currency, and the South China Morning Post reported a new 'hard-wallet' for SIM-based CBDC payments, a joint project

between the Bank of China and Chinese telecommunications giants.

Back to Australia, where it was reported on October 12 that Mastercard and the Reserve Bank of Australia had 'successfully trialled' the interoperability of CBDC systems, whilst ensuring that 'the pilot CBDC can be held, used, and redeemed only by authorised parties'.

Mastercard's report also notes that the benefits of CBDCs are 'programmability, transparency, and compliance.'

Oh, and a new study says eating bugs is good for your metabolism.

So that's progress on...

- Global digital IDs
- Debanking for wrong-think

- Mass surveillance and facial recognition
- Inflated energy prices
- Carbon credits

Gold standard makes for short wars

Printing money out of nothing extends conflicts

ONE of the longest and most stable monetary regimes from the 'early modern era' onward was the British pound on the classical gold standard.

It lasted about 250 years, from the mid-17th century up until the outbreak of World War One. According to the late Ferdinand Lips, in his seminal work *Gold Wars*, if you index the purchasing power of the British pound vs gold starting at a value of 100 in 1664, the reading would have been 92 by 1914.

In other words, over 250 years, the purchasing power of the British pound was not only stable, it had actually increased a little.

Lips goes on to note: 'By 1900, approximately fifty countries were on a gold standard, including all industrialised nations. The interesting fact is that the modern gold standard was not planned at an international conference, nor was it invented by some genius. It came by itself, naturally and based on experience.'

'The United Kingdom went on a gold standard against the intention of its government. Only much later did laws turn an operative gold standard into an officially sanctioned gold standard.'

Pundits and the financial clerisy inform us that monetary systems must be dictated from above and governed from the centre. But it is not so. In fact, when that happens, society puts itself at the mercy of technocratic central planners, who are largely detached from reality and insulated from the consequences of their actions.

Lips goes on: 'In 1914, at the beginning of World War One, the gold standard was thrown overboard within a few weekends. In order to finance wars, the world resorted to deficit spending and paper money.'

'Had the gold standard not been given up, the war would not have lasted more than a few months.'

Instead, it lasted more than four years, ruined most of the major economies in the world and left millions dead in its wake.'

His book, *Gold Wars*, lays out - era by era - the machinations of central banks, governments, even bullion banks and forward-selling miners who were waging open and covert war against sound money.

However, it would be a mistake to assume that the Gold Wars were confined to monetary matters.

The Gold Wars were everything.

We all know the conspiracy theory concerning Albert Pike and his coven of Freemasons who meticulously plotted and planned Three World Wars that would ravage humanity throughout the 20th and 21st centuries before culminating in a one-world government of

Luciferian Marxism (except that the 'prophecy' isn't true).

Since the Russian invasion of Ukraine in early 2022, it's been speculated that future historians may look back on that event as the beginning of World War Three.

And now with the mess in the Middle East, it feels like we are at that point where this could escalate, draw in the great powers and then we will unambiguously be embroiled in another worldwide conflict.

The common thread from a sound money perspective is that none of it would be possible without the ability to print value *ex nihilo* (out of nothing). Fiat currency is a monumental fiction, one that can asset strip the productive segments of the economy, hollow out the middle class, while enriching

the Cantillonaire class, the military-industrial complex and the Deep State.

Reading *Gold Wars* provides clarity around the role of sound money - in rational governance and in providing the basis for harmonious relations among humanity.

Where sound money makes for short wars, fiat money makes for a Forever War, which Lips calls 'The Gold War'.

That war, until now, has been a most effective and ruthless manner of enslaving whole populations while enriching the rulers. If there is a far-reaching, multi-generational international conspiracy - it is one that brainwashes the masses into trading their time, wealth and property for meaningless chits backed by nothing.

And there is more from Lips:

'WWI lasted as long as it did because the gold standard was abandoned. Deficit financing made it possible for it to last over four years, destroying capital wealth, a rich cultural heritage and unnecessarily killing millions of young soldiers and innocent people.'

'If WWI had lasted only six months, currencies would not have been destroyed. There would have been no Versailles Treaty and no German hyperinflation. The little understood Genoa Convention of 1922 was largely responsible for the boom of the 1920s and the crash of 1929 leading to the crisis of the 1930s.'

'Without the mishandling of gold, there would never have been a Hitler. Neither would there have been a Bolshevik takeover by the likes of a Lenin; nor would Russia have had to endure a Stalin with even more millions of innocents killed. There would never have been a WWII.'

'The approaching oil and energy crises of the 21st century, and the future derivatives crisis... are all primarily monetary crises... because the world disregarded gold money.'

In the epilogue to *Gold Wars*, Lips takes stock, remarking that despite all the misery the fiat system and the unrestrained expansion of paper money wrought, there would be a generational opportunity to amass near-dynastic wealth when the world - much like Great Britain in the seventeenth century - reverts to a sound money system over the objections of the world's governments.

One thing is for certain, if we were on a gold standard today, or in the future, we would not be able to go on funding hot wars on open-ended terms, and we wouldn't be in such a rush to ignite a few more flashpoints around the world.

Equal access to law - all that's needed to foster freedom

Kojak cracks the covid case

Apply detective methods to solve pandemic riddle

IF the cold case of prior pandemics landed on the desk of a detective like Kojak, he would first review all the evidence collected at the time.

He would instruct forensic teams to look at autopsy and toxicology reports and, if necessary, exhume bodies.

He would also look at aerial photography, cell tower data, paramedic reports and profiling analysis.

And he would bring in experts that could shed light on alternative theories as to what caused such apparent sickness that spread so rapidly. He would identify any suppressed or missing evidence. Was it missing for a reason? Was there a conflict of interest?

Were those who gained compromised, bribed, threatened or were they instigators of the events?

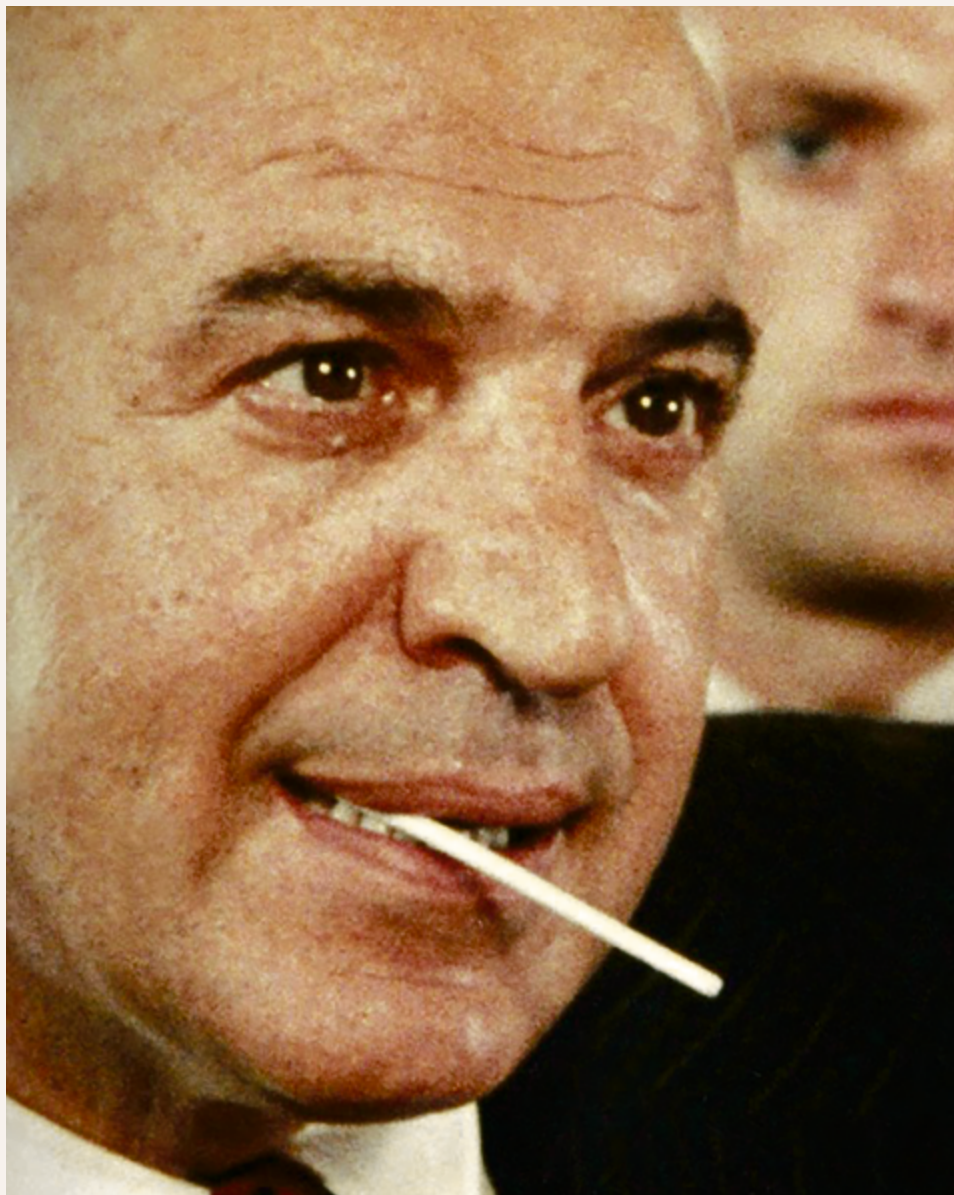
If a pathogen is spread from person to person, there must be a patient zero who then passes their illness on to ten other people, and so on. But how did patient zero become ill? Not from another person, otherwise they wouldn't be patient zero.

Patient zero could have become ill from stress, or through exposure to multiple sources of toxins, whether in the air, water or food. Likewise, so could everybody else become ill from those same toxins. The person-to-person contagion theory has survived because it doesn't seem counter-intuitive to surmise that people getting sick or showing similar symptoms of an apparent illness, in the same geographical location, 'caught' it from each other.

But they are also drinking from the same water supply, breathing the same air, predominantly using the same food sources and are exposed to the same radiation and toxins from industry, and common geographical stressors.

Looking at the most recent pandemic, a detective might wonder why so many apparent deaths from a pathogen were considered contagious or infectious, when 'covid' could have been administered (unwittingly or otherwise) via water, food, injection or a swab, and where the death could or should have been attributed to other factors.

Then there are the changing parameters of manipulative measurement. During the alleged pandemic, the World Health Organisation added new covid codes in 2021 including U07.2 - for 'virus not

identified', and are estimated to account for 8.4% of 'cases'.

Case data was also unreliable due to the low-threshold definition and the repurposed RT-PCR test whose measurement of 'covid' could be manipulated by the value of the Cycle Threshold (CT). Worse still, the government had no knowledge of the CT levels used at any given time, as they outsourced the PCR tests to eighty companies, many of which didn't provide the changing value of CT levels with the RT-PCR results. President of Tanzania John Magufuli submitted several 'covid' samples to the World Health Organisation for RT-PCR testing, each given a fake human name to hide its true origin. Car oil tested negative for covid, jackfruit was inconclusive, a bird and a goat tested positive, as did a pawpaw fruit.

Re-examining older cold case files such as the Russian flu of 1889, a good detective would note that the alleged

pandemic, which killed a million people, had mainly an urban impact, was borne by the European railroads and that contagion in cattle was due to the concerted expansion of the live cattle trade facilitated by the railways. Why settle so readily on a pandemic of contagion when there were alternate parallel factors that might affect human health, such as the electrification of the world - predominantly via towns and railroads?

Arthur Firstenberg's *The Hidden Rainbow* trawls forensically through decades of electrification and the impact of such electrification on the human condition. The so-called Russian flu of 1889 coincided with the mass rollout of electric railways and electric lighting. The Spanish flu of 1918 coincided with the implementation of radio waves; the Asian flu of 1957 with the first low altitude satellites which sent radio signals back to earth; the Hong Kong flu of 1968 with radiation radar satellites fired up into the

atmosphere, and covid in 2019 with the rollout of 5G.

The Diamond Princess, a ship whose passengers were allegedly hit by covid-19 early on, was not only fitted out with 5G, it was docked at Yokohama where FamilyMart Co. and the Panasonic Corporation had joined forces in April 2019 to launch 'the next generation of convenience store', utilising Internet of Things Technology. Panasonic Connect Co. Ltd was also working on the world's first Beyond 5G technologies for automated driving, which launched in Yokohama in 2022.

On November 11, 2019, Elon Musk's Starlink company launched the first 60 low-Earth satellites to provide high-speed internet to every corner of the Earth. Six days later, the first case of covid was reported in Wuhan, China.

While there was electrification of the railways in 1980/81 at the start of the AIDS pandemic, the consensus was that AIDS was the result of a single green monkey. Newspapers of the time depicted emaciated young men covered in cancerous lesions and Africans dying in their thousands, while a TV commercial had the word AIDS being hammered into a gravestone as a doom-laden voice warned: 'Don't die of ignorance.' Initially labelled GRID or Gay Related Immune Deficiency, the 'gay plague' soon became known as AIDS or Acquired Immune Deficiency Syndrome when it became clear that the greater the number who believed they could be infected, the larger the investment in looking for a cure.

A detective would begin to see a pattern. As with AIDS, the covid-era newspapers depicted patients struggling and dying in their thousands. A TV commercial showed masked doctors, nurses and patients staring plaintively into the lens as a doom-laden voice pleaded: "Look them in the eye and tell them you're doing all you can." The UK health secretary at the time texted: 'We frighten the pants off everyone.'

What is incontestable is that each 'pandemic' led to the development of new drugs and vaccines, that the drugs and vaccines were part-funded by the taxpayer, that drugs and vaccines make millions not for the taxpayer but for their suppliers and distributors, and that there was no incontrovertible proof that such treatments did more good than harm.

Green energy anything but green

ONE of the most remarkable aspects of green energy is how non-renewable and environmentally dirty it actually is.

Almost no attention goes to the staggering environmental costs that go into making the mammoth wind towers, solar panels and EV lithium-ion batteries. That grave omission is deliberate.

Solar panels and giant wind-power arrays require huge amounts of raw materials. A standard engineering evaluation between 'renewable' solar and wind versus present nuclear, gas or coal electricity production would begin by comparing bulk materials used such as concrete, steel, aluminium, copper consumed per production of TeraWatt hour (TWh) of electricity.

Wind consumes 5,931 tons of bulk material per TWh, and solar 2,441 tons, both many times higher than coal, gas or nuclear. Building a single wind turbine requires 900 tons of steel, 2,500 tons of concrete and 45 tons of non-recyclable plastic. Solar power

farms require even more cement, steel and glass - not to mention other metals. Keep in mind the energy efficiency of wind and solar is dramatically lower than for conventional electricity.

A recent study by the Institute for Sustainable Futures details the impossible demands of mining for not only EV vehicles but also solar and wind farms. The report notes that the raw materials to make solar PV panels or windmills are concentrated in a small number of countries - China, Australia, DR Congo, Chile, Bolivia and Argentina.

The report says: 'China is the largest producer of metals used in solar PV and wind technologies, with the largest share of production for aluminium, cadmium, gallium, indium, rare earths, selenium and tellurium.'

'In addition, China also has a large influence over the market for cobalt and lithium for batteries. While Australia is the largest producer of lithium... the largest lithium mine, Greenbushes in Western Australia, is majority

owned by a Chinese company.'

Not so good when the West is escalating confrontation with China.

The report notes that the DR Congo mines more than half of the world's cobalt. The mining there has led to 'heavy metal contamination of air, water and soil... to severe health impacts for miners and surrounding communities in DR Congo, and the cobalt mining area is one of the top ten most polluted places in the world. Around 20 per cent of cobalt from DR Congo is from artisanal and small-scale miners who work in dangerous conditions in hand-dug mines and there is extensive child labour.'

Rare earth metals mining and refining is essential for the 'zero carbon' transition in batteries, windmills and solar panels. According to one report by energy specialist Paul Driessen: 'Most of the world's rare earth ores are extracted near Baotou, Inner Mongolia, by pumping acid into the ground, then processed using more acids and chemicals.'

'Producing one ton of rare earth metals

releases up to 420,000 cubic feet of toxic gases, 2,600 cubic feet of acidic wastewater, and a ton of radioactive waste.

'The resulting black sludge is piped into a foul, lifeless lake. Numerous local people suffer from severe skin and respiratory diseases, children are born with soft bones, and cancer rates have soared.'

The USA also sends most of its rare earth ores to China for processing since it shut down domestic processing during the Clinton presidency.

Because they are vastly less energy efficient per area, the land used to produce the mandated zero carbon electric output is staggering. Wind and solar require up to 300 times the land required to produce the same electricity as a typical nuclear plant. In China, 25 square kilometres of a solar farm are required to generate 850 MW of electric power, the amount of power attained at a typical nuclear plant.

Quiz for behavioural scientists

Unknowing taxpayers are funding their own manipulation

STATE-FUNDED behavioural scientists - via their application of often-covert 'nudge' techniques - fulfil a crucial role in imposing the will of the rulers upon ordinary people.

Whether it is confining us to our homes, encouraging the ingestion of insects, imposing digital ID or restricting our opportunities to travel, the nudgers promote the compliance of the masses by a variety of means, including their stealthy harnessing of fear, shaming and collective peer pressure.

And behavioural scientists are now a prominent occupational grouping within the government infrastructure. The 'Government Communications Service' employs more than 7,000 'professional communicators' across the UK, and incorporates a 'Behavioural Science Team' (based in the Cabinet Office) with a central goal of embedding behavioural science expertise across the Government Communication profession.

During the covid event, the Cabinet Office granted the Behavioural Insight Team (the original 'Nudge Unit') a £4m contract to furnish the government with 'frictionless

access to behavioural insights to match central priorities'.

Recent Freedom of Information (FOI) requests to the Cabinet Office and the Department of Energy Security and Net Zero, asking how many behavioural scientists they currently employed were refused on the grounds that it would take too long to compute the information. Ironically, it seems that taxpayers are generously funding their own manipulation.

A prominent UK behavioural scientist recently acknowledged the impact this intense nudging campaign has had on the British people. In a 2023 interview for *The Telegraph*, Professor David Halpern (the Founding Director of the Behavioural Insight Team), observed that people are now 'drilled' and rightly calibrated to accept further restrictions.

He said: "Once you've practised something (lockdowns, mask wearing) you can switch it back on... you've got the beginnings of a habit loop... we've practised the drill."

HART (Health Advisory & Recovery Team) believes that the general public has a right to be informed about the nature, scale, and intensity of state-sponsored nudging, not least so that they can be furnished with the opportunity to express their opinions about

the appropriateness and acceptability of this unseen form of top-down persuasion.

Yet, to date, there has been a stark reluctance for any of the behavioural scientists within the government infrastructure to admit responsibility for promoting the fear-inflating messaging witnessed throughout the covid event.

Given this lack of transparency in regard to the details of the ongoing behavioural science operation, HART would like to ask the state-employed nudgers the following questions:

1. Do you perceive yourselves as advisors or enablers? Is your primary goal to provide expert guidance to ministers and civil servants, or to maximise the compliance of the masses with government edicts?
2. Did you conduct your own independent evidence reviews before promoting the implementation of top-down restrictions such as lockdowns and community masking, or do you presume that all recommendations emanating from national and world public health bodies are for the 'greater good'?
3. Do you recognise the ethical concerns

arising from the government's deployment of nudges upon their own citizens? How much time do you devote to discussing the morality of using often-covert, distress-inducing methods of persuasion upon ordinary people?

4. If, as you claim, you have never endorsed the use of fear-inflation as a means of promoting compliance, why did you all remain silent throughout the covid event while our government was 'scaring the pants' off us?
5. Do you recognise, and allow for, the fact that your own ideological biases will be colouring your judgements and actions?

By answering these questions, and thereby filling in some of the information gaps surrounding the government's ubiquitous use of nudging, lay people will be better placed to make an informed choice as to whether they want their taxes spent on this often-clandestine activity.

We look forward to receiving responses from the behavioural scientists concerned.

James Corbett - our man in Japan

Journalism legend on technocracy and life in Far East

What woke you up, and how and when did you get begin to dive into the truth?

In 2006, I was just coming back online, so I watched documentaries - history, politics, etc. - it was still 'the wild west' of the internet, so the 'suggested section' would have these conspiracy theory videos, and I'd watch them initially for a lark. But once I'd started looking these claims up for myself - Operation Northwoods, for example - there's the actual document I can read for myself, I started falling down the proverbial rabbit-hole. From there, 9/11 truth was the first thing that really grabbed me, and as the ball rolled downhill, I realised we'd been lied to about everything.

I'd never planned to be involved in media production. I started a podcast - the original idea was one half-hour show every week. But then I realised I had to start interviewing people, then writing articles, then I've got to do videos, and here we are.

How did the famous 5-minute 9/11 summary come about?

I had the opening lines of that kicking round in my head for a few weeks. I knew I had to do something for the tenth anniversary of 9/11, and I thought it was kind of funny if you say it really quickly. On the actual day in 2011, I wrote the script and recorded it and intentionally made it look like this poorly-edited conspiracy theory video, so it really didn't take long to put together. I literally made the entire thing in my living room wearing my pyjamas on that Sunday.

I woke up the next day and it had already had a few hundred thousand views and by the end of the week it was approaching a million (link at end).

You obviously have a lot of creative abilities, but you haven't mentioned artistic ambitions?

I started out as a Physics major at the University of Calgary, and I did alright but it was soul-crushing; I wasn't happy at all. One day, I decided I didn't want to do it any more, so I signed up to English,

History, etc. I always said I'd never be a teacher and I'd never be a journalist. And then I moved to Japan to become an English teacher and ended up being a journalist.

Do you speak Japanese okay?

I wouldn't say 'fluent', because there are certain topics I can talk to people about no problem, but there are others where I'm missing the vocabulary.

I'm always fascinated when people move to completely different cultures and live there for years - it shows how adaptable we are doesn't it?

It's a great experience; it's something to do when you're young and you still can. I remember when I was coming here, I was expecting the laws of the universe to be completely different, like it's a different planet; but it's pretty much the same as everywhere else, though there are obviously still subtle cultural differences.

I've been here 19 years, so my entire adult life has been in Japan. I'm really not Canadian any more.

How far and deep is the NWO technocracy in Japan?

If there is a part of the world that's not going to be affected, I don't know where it is. Japan is no exception, but it will look different. Because Japan has that history of cultural isolationism. It shut itself off for centuries from

the outside world.

Basically, it's one ruling party which has been in charge for 80 years. Whatever political actions and differences happen within the ruling party itself, so it's a weird system that doesn't quite look and feel like the West, but Japan since WWII has played ball with the cabal - it was a founding partner of Trilateral Commission; the Japanese rulers wanted a seat at the table. They became America's proxy so they could enjoy their economic status.

Things are starting to change, and one of the most obvious examples has been the change in the constitution. Article 9 says Japan will never have a military and renounces war. Pretty startling, and of course it's not true and it's never been true; I think Japan has the fourth or fifth largest military by expenditure, they just don't call it a military - it's a 'defence force'.

And then you have the infamous demographic change, the population is getting very old and shrinking. There are nearly a hundred thousand 100-year-olds - so more adults in diapers than children.

Are you getting the same push for digital ID and CBDC (central bank digital currency)?

Yes, they just frame it as going along with the international consensus. We've had biometric scans for decades for when you arrive in the country. Now it's

normalised, justified by the fact that other countries are doing the same.

The same agenda is being rolled out. It's essentially a neo-feudal system here - instead of the shoguns, you have the corporate boss and you do whatever he says. So when the corporations said 'everyone will get their injection and line up on this date', everyone lined up and did it. That obviously showed a lot of compliance.

But having said that, because it's 99 per cent Japanese, there's still that closeness of family ties, and society in general - it's still a high trust society, and that manifests in resilient ways, and will probably surface in the event of a crisis. One thing I take for granted is how much of a cash-based society Japan is. I definitely felt that on my recent trip to England, where many stores had 'cashless' signs up and so on. In Japan, everyone pays cash for everything. Also every family has a rice paddy that they harvest, and share all their produce out at the office. They still have that tie to reality - which you don't get in major cities in Canada, for example, where they are de-rooted from nature.

In the West we have a big resistance movement, how's it in Japan?

There are underground groups - a version of Q Anon for example. Some people went into the mass vaccination clinic, handing out info and they got arrested for trespassing. I once went to a 9/11 truth conference in Osaka, and there was a Japanese politician who used to give speeches about 9/11 on the floor of the parliament. It's difficult to know what the Japanese person really believes, because they have this concept of 'there's what you show to the world, and then what you really think, at home.'

So compliant but more resilient?

Either a nation flips over and does what it's told, or it will be surprisingly resilient. I think there is a Japanese spirit that just doesn't want to assimilate.

What do you think are the best solutions, what should activists

be doing, how do we evade the inevitable?

Something small, something medium and something big.

It's all of it together, not - either or - push all the buttons!

Small tiny things - filter your water. Also, 'salt' your data - don't tell the internet and these companies all of your real information, unless it's a legal requirement. Put creative data into the system, so they don't know everything about you.

The really big solution is to have a new form of currency, but intermediate - cash Fridays. Commit yourself to just using cash all day on Friday, one day a week. If there's a shop that you can't go to, go somewhere else. See how that works. Expand it - cash weekend, etc.

And then the big picture things - for example, writing a new narrative. Klaus Schwab sets out their grand vision for 2030; well maybe we need to have our own vision and start setting goals too! That's a huge thing that can take any number of forms - including making a newspaper.

Build an understanding. The point about alternative currencies is not the currency, it's the community. It doesn't matter what you use. Without a community, it doesn't matter what currency you use even if it's the best thing ever.

Are there any subjects you won't touch?

The founding ethos of the Corbett Report is that it's the CORBETT report, so it's whatever I want to talk about, whenever I want to talk about it, where ever, how ever I want to talk about it. I'm very fiercely, stubbornly independent, and I will not be told by anyone what to talk about or what not to talk about.

Adversity brings enlightenment

Shane Fudge interviews entertainer-cum-freedom fighter Richard Vobes

Shane Fudge [SF]: Can you tell us a little about yourself, Richard?

Richard Vobes [RV]: I suppose I am an entertainer mostly, and a filmmaker. I used to think of myself as being a bit like Richard Attenborough, where I could direct myself. I am a Leo, so I suppose that is the flamboyant, egotistical side of me.

I worked for a printer after school, and I then went into mime. I would juggle, ride a unicycle, lie on a bed of nails, walk on broken glass, fire eat - all those skills. I would also do things like gala shows and corporate events.

Then I lost my eye due to a condition called *acanthamoeba* and I had to curtail the more physical activities. After that, I wrote and produced a children's television programme for Scottish Television called *Snug and Cozi*. More recently, I started a show on YouTube called *The Bald Explorer*, looking at English heritage, landscapes, and nature.

[SF]: At what stage did you begin to question things?

[RV]: Because of my background in filmmaking, when I first saw those Chinese videos coming out, with people falling over, I thought 'these just look fake'. Chris Whitty then told us: "There is nothing to worry about unless you are over eighty or have serious comorbidities." Then the whole narrative turned into something like the Black Death - lockdowns, 'flattening the curve', and all that nonsense. I did start talking about it all in my YouTube show, but many people seemed to feel that the government knew best.

I then came across Neil Oliver on *GB News* talking about the fuel crisis, the one where he asked: "What would happen if nobody paid their bills?" I thought this was interesting, so I made a YouTube video posing similar questions. I realised after my viewing figures increased that there is an audience, and that people did want to talk.

I began doing my own monologue in the morning and then interviewing guests in the afternoon. I just let people speak and

didn't shoot them down or dismiss what they had to say. I just wanted them to be heard, which the audience seemed to appreciate.

[SF]: Where do you get the inspiration for content?

[RV]: A lot of my viewers will send me stuff or tell me what is going on. I might speak to somebody and think: "Oh, I know, that will make a video." So I do that in my monologues. My guests just come out of the woodwork, and they say: "I don't know whether you would be interested in this?" And I will say: "That sounds interesting, let's put you on the show." My shows try to inform but attempt to look for solutions as well.

[SF]: Are you able to tell us a little about the YouTube ban you received a while back?

[RV]: I had Andrew Bridgen on in January. Then in March, out of the blue, I had a 'violation', and they just removed the interview. Apparently, it breached terms and conditions, specifically WHO guidelines on 'medical misinformation'. I said to them: "Bridgen is a sitting MP talking about his experience with the Yellow Card System." Within an hour, it had gone. Two days later, they had found another video with Dolores Cahill and they just removed it. Now it was a strike. I didn't stop though, I set up on Rumble and it didn't really change anything,

other than a seven-day break.

[SF]: How do you prepare, knowing the level of censorship on YouTube?

[RV]: It was very clear that any mention of the vaccine was a 'no'. In a free press, it's what you wanted the journalists to be asking: "What's the efficacy of this vaccine you are mandating?" So, then you come up with different terminology. This makes it quite interesting for the audience, because they know exactly what you are referring to when you call it a 'medical intervention'. I was still on the naughty step until August, but then I feel that my head is now above the parapet anyway.

[SF]: Do you think that people are waking up at the rate that is needed to challenge what is happening?

[RV]: I do. I think the vaccine business has woken people up, and then because they are rushing in all these other things like ULEZ (Ultra Low Emission Zone), it is bringing more and more people together.

[SF]: Do you have any views on the Covid Inquiry?

[RV]: Because I think that the whole government system is corrupt, I think it will be whitewashed and made to seem like there were 'a few mistakes'. I don't really know what the government can do because they can't admit to giving people midazolam and killing them, and they can't admit that they knew the vaccine

was neither effective nor safe.

[SF]: How far down the line as a percentage (0-100) has the UK progressed to operating as a top-down, authoritarian state?

[RV]: Well, to me it is right up the high end, say 80-85 per cent, but I don't think that half of people know that it is. I mean, they are implementing all of these policies on the justification of 'following the science', but we saw after the vaccine rollout that this wasn't necessarily a good idea. Are we sure that global warming is correct? They can't turn around and say: "Oh sorry, we got it wrong." They are so up against the wall that they have nowhere else to go other than continuing with the narrative. In the past, I was a firm believer in voting, but now, if you vote, I think you are acquiescing. They don't adhere to any manifesto, and they never have done.

[SF]: Do you have a positive message that you can share with *The Light* readers, Richard?

[RV]: Although I think things are going to get a bit rough, with adversity comes enlightenment and whatever happens will wake more people up. It's all of us against those who want to kill us and reduce us to 500 million.

Battle of the Naomis

Conspiracy author 'blinded' by right-left political paradigm

Book review: Naomi Klein's Doppelganger

ONE of the many unanswered questions of the past three years is why so few of the public figures who would regard themselves as being on the Left have spoken out?

They will have seen the abuses of power perpetrated under the pretext of protecting the public from an infectious disease. Public declarations of resistance have come principally from political conservatives or right-wing libertarians.

Now we have an answer, from the self-described anti-capitalist social-justice campaigner Naomi Klein, in her new book *Doppelganger*. As Klein openly admits (pp. 117-122), she and her fellow travellers failed sufficiently to investigate the potential adverse consequences of lockdown and of the covid vaccines.

This was for the reason that this territory had already been occupied by the Right - 'because we didn't want to be like them'.

A brave confession, and an embarrassing one. That many people on the Left shied away from investigating the truth because people on the Right were doing so.

That, whatever their previous positions might have been, when it came to covid, they abandoned their own principles and meekly fell into line behind their governments. What hypocrisy! What cowardice!

One of the few public figures from the Left to have braved the harsh criticism of supposed colleagues and spoken out against state over-reach in the name of covid is another outspoken Jewish-American feminist commentator with whom Klein is often confused - Naomi Wolf.

Klein says she has written her

book *Doppelganger* in order to try to understand the confusion between the two Naomis. Or rather, to use this confusion as a jumping-off point to unravel what she considers to be a 'mirror world' of 'conspiracy theories' - to use Wolf as an exemplar to generalise about what Klein sees as an entire 'conspiracy movement'.

Yes, of course Klein has chosen Wolf as her exemplar because the two of them are frequently confused: that's why Klein has come to see Wolf as her doppelganger - her evil twin - but might Klein not also have chosen to write the book in order to denigrate someone that she feels has betrayed the party line and shown up other members of the Left as traitors to the cause they had once believed in?

And while the doppelganger concept is an interesting one, it backfires on Klein in an embarrassing manner.

I used to be a fan of Klein. Her book *The Shock Doctrine* (2007) transformed my understanding of the world. It described how the American military-industrial complex has for several decades started wars and destroyed whole countries in order that American businesses could make a fortune by rebuilding these countries upon American corporatist principles.

The Shock Doctrine foreshadowed what has been done to Western countries since the announcement of the covid 'emergency' in the spring of 2020. The guns that had previously been turned on 'developing' countries have been turned back on the 'developed' ones. Former 'liberal democracies' are being hollowed out, in order to 'build back better'.

To judge from a reading of *Doppelganger*, Klein herself has not read *The Shock Doctrine*. If Klein had really understood the message of her own book from 16 years ago, she would not now have written a book dedicated to debunking what she regards as a dangerous conspiracy theory. She claims it is a conspiracy theory that the whole covid emergency was planned - or at the very least, exploited - in order to introduce a new form of totalitarianism in the form of 'technocracy', an attempt to control and diminish the lives of the citizens of Western countries through technological means.

The Naomi Klein who wrote *The Shock Doctrine* would have called out the Naomi Klein who

has written *Doppelganger*. The doppelganger concept has backfired on Klein, because surely the Klein of 2007 would regard the Klein of today as her doppelganger, her evil twin?

In writing it, Klein appears to have abandoned the intellectual rigour she demonstrated previously. She combats what she describes as unsubstantiated assertions by Wolf by offering unsubstantiated counter-assertions of her own. She seeks to ridicule Wolf and her fellow 'conspiracy theorists', without offering evidence as to why she thinks they should be ridiculed. She accuses Wolf (p. 36) of 'saying things that sounded a little like the argument I had made in *The Shock Doctrine* but refracted through a fun-house mirror of plots and conspiracies... I felt like she had taken my ideas [and] fed them into a bonkers blender.'

I'm sorry, Ms Klein, but simply telling people that they have misunderstood your book is no substitute for explaining to people *why* you think they have misunderstood your book.

Later in *Doppelganger*, Klein has included a section entitled 'Some Conspiracies are Real' (pp. 235-240). Which conspiracies are real? Well, the ones that Klein tells us we should believe, apparently. Not the other ones, the ones Klein tells us not to believe - only she doesn't explain to us why we shouldn't believe them. She simply expects us to take her word for it.

For example, Klein tells us that we should believe that there

was a conspiracy by the United States government and its intelligence agencies to effect the violent overthrow of the socialist Allende administration in Chile in 1973, so that they could use the country as a Petri dish for previously untested 'neo-liberal' economic policies.

But, she says, we should disbelieve the 'conspiracy theory' that the United States and other Western governments used lockdowns to overthrow constitution and the rule of law so that they could use their own countries as Petri dishes for the increased digitalisation of their economies as a means of greater social control.

Yet that's exactly the kind of explanation Klein embraced in *The Shock Doctrine* - a book that was criticised by reviewers for supposedly over-indulging in 'conspiracy theories'.

Now she is telling people that they should disbelieve their own convictions, their own memories and the evidence of their eyes.

If only Klein had read and properly understood the message of the book she herself had written in 2007, perhaps she might instead have followed Wolf along her path of enlightenment.

NLP - focusing on the positives

Part 3 of an interview with NLP expert David Molden

Richard House [RH]: We've felt the need to speak of how neuro-linguistic programming (NLP) has been nefariously deployed. Remind us about how NLP can be a force for good.

David Molden [DM]: NLP is like any other tool - what it's used for depends upon the one using it. Is a knife, a length of rope, or a hammer, useful or dangerous?

But to your question, rather than answer what NLP can do, ask anyone who has attended an NLP course how it has positively affected their life. In a simple sentence, NLP gives you the tools to remove the barriers in your mind that are holding you back from being the person you aspire to be. I meet so many people today, young and old, holding on to stress, worry, fear, self-doubt, low self-esteem, uncertainty, guilt, overwhelmed and feeling awkward in social settings, or simply too nervous to speak out in a group. I meet people who've so much talent and potential, yet stick to a job they dislike simply because they doubt their own abilities, have a fear of failure or taking a risk. These 'mind-states' are all preventing true human potential from flourishing.

[RH]: Can you give a specific example?

DM: Let's take one of the above mental states, for example self-doubt. How does a person create this state for themselves, and what does it look, sound and feel like when they're doubting themselves? What is their body posture like? What is the tone of their internal dialogue, and what are they saying to themselves? Do they have an image in their mind whilst in this state? Do any memories come to mind, perhaps from a parent or teacher, which caused self-doubt? The first step to personal change is recognising

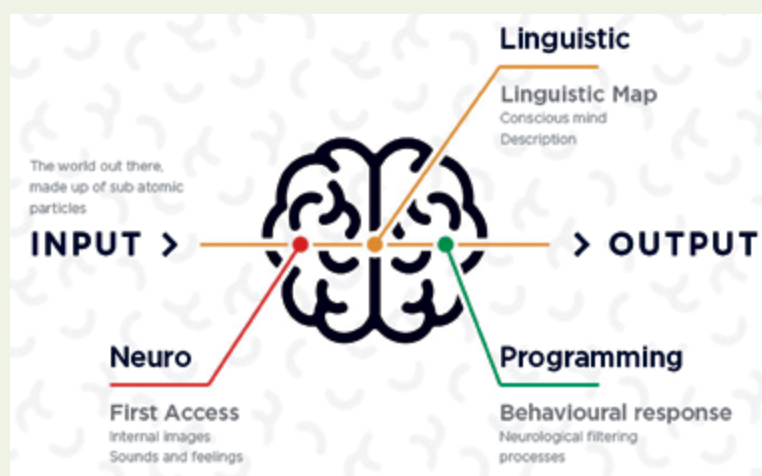
the process by which a state of mind manifests. Then there are many practical techniques to change this process into one where self-doubt is eliminated and replaced with a renewed self-confidence.

[RH]: Give us some examples of practical techniques - how much committed practice is needed for them to work? And should people work with an NLP therapist, or can this be a self-help process?

DM: In my experience of running NLP courses, the most effective solution is to attend a course. In the early days of NLP, courses were 22 days' duration spread over six months. More recently, some companies began to offer intensive seven-day practitioner courses. A course isn't just about teaching the techniques: it's a change process that involves deep introspection of Identity - values, beliefs, behaviours, habits, strategies, physiology, feelings and mind states. You learn how all these aspects of your neurology contribute to forming your unique 'Map of the World'. A core aspect of the learning process is recognising that 'The Map is not the Territory', 'The Menu is not the Meal'.

As everyone is unique in how they form their map of the world, any intervention has to fit with the individual's constructs and responses. When relieving stress, for example, we want to know the process by which someone creates stress, identifying all the triggers that start the process - e.g., an internal image, a sound, a voice, a smell, even a taste. It could be any external event reminding the person of a past stressful time. This latter event is called an 'anchor' (cf. Pavlov's dogs experiment).

Values and beliefs will also require some reframing. A woman I worked with said she wanted to stop being angry when thinking of a certain person. Part way through eliciting her process for creating anger she stopped, and with her body as stiff as a board, said: "Well, I deserve to be angry!" Clearly a value she'd decided to adopt was the main barrier to



getting rid of the anger. I offered her a reframe - something like: "OK, I get that, and in deserving your anger are you also deserving of the harmful stress it's creating for you? Is this what you want every time you remember this person?" During the reframe, her body lightened up and she was able to continue with the exercise.

All the negative reactions that we manifest are deep-rooted

in the central nervous system and rarely surface in conscious awareness. An NLP practitioner/therapist can certainly help - engaging a personal therapist may give you comforting confidentiality, but immersing in a group course can seed more openness to delving deeper. It's common during and after a course to burst into fits of laughter, as attendees recall how they used to be, once they've exorcised their inner demons and discovered new ways to bring joy and positivity into their lives. Laughter is a key aspect of NLP training.

[RH]: Great! I did loads of group work (1980s/90s) but, sadly, professionalised one-to-one therapy has displaced most group work. How would you advise a reader wanting to pursue NLP?

DM: First, decide why you want to learn NLP. If you just want a Practitioner Certificate, you could take an online course. If you want to make positive life-changes and integrate NLP skills, don't make online, cheapest or nearest the deciding factors, and don't be convinced by endorsements from certifying organisations. NLP trainings vary vastly. Some specialise in therapy, some business, some leadership. Group sizes also vary, from 12 to many thousands in one room. Research and find a company that's right for you. And do go with an open mind. Be fully alert and engaged all the time, openly sharing your feelings with the trainer and other group members, and offering yourself for demonstrations when asked. Above all, it'll be fun and life-changing.

Shocking history of Hamas

Politicians building 'orgy of hatred' against Palestine

ISRAEL has financed and supported Hamas Islamists in Gaza.

And the Parliamentary Assembly of the Council of Europe has recognised Hamas as a 'Partner for Democracy', while the Hamas manifesto calls for the whole of Israel, Gaza and the West Bank to be turned into an Islamist state.

The European Centre for Law and Justice - an international, non-governmental human rights organisation - reports that the Palestinian Legislative Council represents the Palestinian territories and is chaired by Abdel Aziz Doweik, a member of Hamas.

Of the Palestinian council's 132 members, 74 represent Hamas. They were elected in 2006, and the authority has not held legislative elections since.

The council has the right to send a delegation to the Council of Europe and speak at the Assembly, take part in committee meetings, make proposals concerning the agenda, sign motions for resolutions, and participate in the work of the political groups.

In other words, a Palestinian parliament in which Hamas has a majority has the status to officially influence the Council of Europe.

And leading Israelis admit their own role in the creation of the Hamas threat. The former Israeli Prime Minister, Yitzhak Rabin, has said: "Supporting and creating Hamas was Israel's fatal mistake."

Former Gaza Commandant, Brigadier General Yitzhak Segev, is reported to have said: "The government gave me money to spend on supporting the Islamists in Gaza to prevent the growing influence of Fatah and the communists."

Rabbi Avner Cohen, who was in charge of religious affairs in Gaza for 20 years, is reported as saying: "Hamas, to my great regret, is a creation of Israel."

In the 1980s, he prepared an entire report for the Israeli government, concluding with a warning about the threat of a terrorist Islamist cell and, as a consequence, a strong recommendation to immediately stop playing divide and conquer in Gaza. One of his quotes on the subject was: "Stop supporting this monster before you face the dire consequences."

Given this admitted history of collaboration with Hamas, it was surely totally unacceptable for Israel's President Herzog to say: "It is an entire nation out there (Palestine) that is responsible. It is not true, this rhetoric about civilians not being aware, not involved. It's absolutely

not true. They could have risen up. They could have fought against that evil regime which took over Gaza in a coup d'etat."

The evil of the Hamas massacres involving the torture, burning and killing of men women and children can neither be denied nor forgiven.

But in pursuit of the perpetrators, Israel threatens to sow the seeds of even more hatred and revenge, as Palestinian civilians (50 per cent of the Gaza population are children) become, at best, horrendous 'collateral damage'.

Some 7,500 died even before the Israeli ground offensive started - many times the number of Israelis who died in the Hamas attacks.

The long-term failure to solve the Israel/Palestine crisis (whose origins lie in the Zionist movements in Russia, Germany and Britain in the late 19th century, British promises to both Jews and Arabs during the First World War, and the creation of the State of Israel by the UN in 1948,) led to the rise of extreme Islamism and this permanent murderous conflict.

It has descended into an orgy of hatred, genocidal killings and international crisis.

Herzog's "it is an entire nation that is responsible" is reflected in the words of Defense Minister, Yoav Gallant, who said: "No power, no food, no gas," and

"We are fighting human animals, and we act accordingly."

And of course, U.S. Senator Lindsey Graham continues to spout his bigotry so long as the peoples of other nations do the dying: "We are in a religious war. I am with Israel. Do whatever the hell you have to do to defend yourself. Level the place."

It has become a religious war of the fiercest kind thanks to the actions, inactions and historical ignorance of American politicians like Graham, fresh from his 'successful' geopolitical strategy in Ukraine.

Just as in Ukraine, Kiev's troops murdered surrendering Russian troops, so we have come from the killing of pop festival-goers to the murder of Palestinians by Israeli soldiers.

The present situation in the Middle East was created by 4,000 years of history, and by the European powers and the League of Nations during and after the First World War, and by the UN in 1948. Those external actors who draw maps and create conflict must live with the permanent duty to solve the crises their forefathers created.

Exploring motives for slaughter

Israel bombing could spark much wider conflict

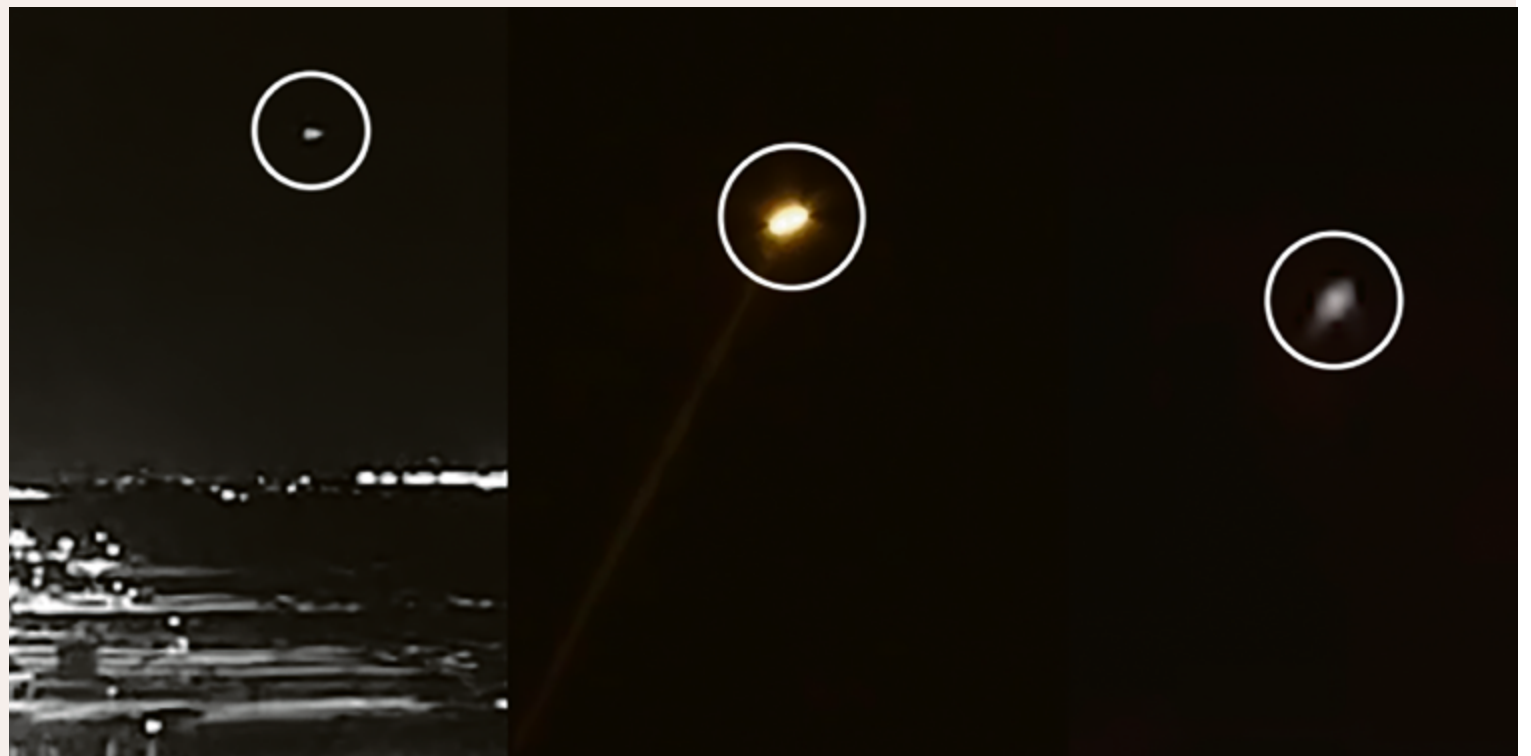
THE bombing of Gaza's Al-Ahli Hospital on the October 17, killed in excess of 500 innocent men, women and children.

This fact, both sides agree on. In eight days, Israel fired over 8,000 missiles into Gaza, each capable of demolishing apartment blocks, schools, mosques, bakeries and hospitals; the *Washington Post* reported that the tonnage of bombs that Israel dropped on the Gaza Strip in just six days is more than the U.S. dropped on Afghanistan in an entire year.

Any missiles fired by Hamas out of Gaza are fired from home-made rockets, as Israel controls all imports into this enclosed zone that houses over two million people, more than half being children under sixteen. Common sense suggests that the bomb was fired by Israel, much as common sense suggests that Russia did not blow up their own Nord Stream pipeline. Time and time again, the western media take these disasters and twist them for their own agenda. All the media-talk is of who fired the one bomb on the hospital, giving the excuse to ignore the thousands of other bombs that definitely were fired by Israel, and which have caused massive devastation and a death toll already standing in excess of 8,000, with tens of thousands injured.

The bombing was in response to the terrorist excursion into Israel on Oct 7, when an estimated 1,000 Israelis were killed and over a hundred taken hostage. The 40-mile security barrier between Israel and the Gaza Strip took more than three years to build. Finished in 2021, the barrier is a technologically advanced mixture of 20-foot fence, radar systems and underground sensors. The fact that Hamas 'terrorists' with trucks, motorbikes, tractors and even parachutes and hanggliders, managed to approach the barrier without detection is remarkable, but to blow holes through one of the best-defended borders in the world undetected is unbelievable. The most astonishing thing of all, that the world's media is ignoring, is that hours later these same 'terrorists' managed to take over 100 Israeli hostages out of Israel and into Gaza, presumably through the same holes in the walls that had remained unmanned through the whole raid.

Israeli Journalist, Efrat Fenigson said: "I served in the IDF (Israel Defence Forces) 25 years ago in the intelligence services. There's no way, in my view, that Israel did not know what's coming. Something is

very wrong here."

There is a great deal that is wrong here; nothing could be more wrong than the indiscriminate bombing of heavily populated cities because a few hundred combatants with hostages have hidden amongst two million people. Israel turning off the water and electricity, and stopping all food, fuel and medical supplies is so clearly wrong, yet the UN resolution to bring a ceasefire was thwarted by the U.S., citing Israel's right to defend itself!

Instead of condemning the carpet bombing, U.S. President Joe Biden said there were "confirmed reports of Hamas beheading babies". Of course shortly afterwards, the White House 'walked back' the disinformation. Ten minutes' research reveals there was never any truth to this fake news, yet it still made the front pages of UK newspapers.

Many still remember the story of Saddam's troops taking Kuwaiti babies from incubators and throwing them on the floor. That too was proved to be a lie, yet a lie that helped to justify the Gulf War. Such lies are spread to hoodwink a gullible public into accepting the fact that the West is about to commit atrocities on a monumental scale.

In 2007, Wesley Clark, a U.S. four-star general, revealed classified Pentagon plans to take out seven countries in five years, "starting with Iraq, Syria, Lebanon, Libya, Somalia, Sudan, and ending

with Iran" (<https://www.youtube.com/watch?v=iyrkZpiYwoM>). The press has wasted no time in linking Iran to Hamas in Palestine, and Hezbollah in Lebanon.

The relationship between the U.S. and Iran is poor; released documents show that in 1953, the CIA (and MI5) organised a coup to oust Iran's democratically elected prime minister, Muhammad Mossadegh. Iran has huge oil resources, and it is no secret that the U.S. wants control of those oil fields. If Israel continues its slaughter of civilians, then it is likely that Iran will openly oppose Israel and give the excuse for the U.S. (and UK) to tick another country off the list.

Iran is expected to join the BRICS nations in 2024. Individually, Brazil, Russia, India, China or South Africa would never pose a threat to the West, but with the addition of Iran, as well as Saudi Arabia and Argentina, collectively they would pose a serious economic threat, particularly to the U.S. and the petrodollar.

While electric cars may be the new vogue, tanks and fighter planes and the whole military complex rely on oil. Presently, all oil has to be traded in dollars. This petrodollar system is very relevant today, as part of the agreement that the U.S. struck with Saudi Arabia back in 1973 was that the U.S. would protect the Arab nations from Israeli expansion if they agreed to trade oil in dollars.

This agreement has lasted for 50 years, but if these countries choose to trade oil

in the yuan, the rouble or in gold, then the U.S. is no longer obliged to protect Arab countries from Israel.

However bad a terrorist attack is, it can never give justification for the killing of thousands of innocent men, women and children by the deliberate bombing of residential areas, as that is just answering terrorism with more terrorism. After 9/11, the Patriot Act led to the invasion of Iraq and Afghanistan, imprisonment and torture without trial, massive surveillance, and even to 'domestic terrorists'.

The attack against Israel on Oct 7 by Hamas was despicable, but many have questioned why the retaliation has been so disproportionate, and why western leaders have refused to condemn this collective punishment inflicted on innocent people. Perhaps the excuse is to take possession of the Gaza strip and to provoke Iran at the same time?

Thousands of men, women and children are being blown to pieces or lie trapped under rubble; thousands more are dying in hospitals with no power, no water and not even basic supplies.

What is worse for these proud people, whose ancestors have lived on these lands for thousands of years, is that once the dust has settled and the media has labelled them all as terrorist sympathisers, there is every chance that their land will be stolen from them.

Failed referendum cost \$450m

Taxpayers foot bill for 'personal vanity project'

THE failed Albanese Voice referendum - concerning the 'recognition' of indigenous people - has come at a huge cost to Australian taxpayers.

Jabs linked with seizures

A POSSIBLE link between seizures in young children and covid injections has been detected by the U.S. Food and Drug Administration.

Researchers with the FDA and three large healthcare companies said in a new preprint study that seizures and/or convulsions 'met the statistical threshold for a (safety) signal' in children aged two to four following receipt of a Pfizer covid-19 injection, and in children aged two to five following receipt of a Moderna jab.

A safety signal is a sign that a health condition may be caused by vaccination, but further research is required to verify a link.

The data came from three health claims databases run by Optum, Celeron Research, and CVS Health, supplemented with vaccination information from state and local systems.

Researchers looked at 15 health conditions following vaccination entered in the commercial databases, and compared rates among children aged six months old to 17 years old to background rates from 2019, 2020, or both.

Overall, 72 cases of seizures/convulsions were recorded within seven days of a shot among toddlers and other young children.

Most happened within three days of a shot.

The researchers found safety signals for dose one and dose two of Pfizer's shot in two of the three databases in children aged two to four. They also found a signal following dose two of Moderna's shot in children aged two to five.

There were reports of seizures and convulsions after covid shots among children in the Vaccine Adverse Events Reporting System (VAERS), the researchers noted. Though anybody can lodge reports with the system, most are made by healthcare professionals.

Another five convulsions were reported after Pfizer shots in its clinical trial.

The research did not cover the bivalent covid injections that were introduced for some populations in 2022, and completely replaced the old shots in April, or the newest versions of the jabs that were rolled out in September.

It's not clear when the signal was first detected. The FDA and Patricia Lloyd, an FDA statistician who is the study's corresponding author, did not respond to requests for comment from *The Epoch Times*. Pfizer and Moderna did not return inquiries.

The researchers said the signal 'should be interpreted with caution and further investigated in a more robust epidemiological study.'

Similar to previously analysed data from the

same system, the researchers also detected a signal for heart inflammation and a related condition, or myocarditis and pericarditis, for children aged 12 to 17. Because that signal has been known since 2021, researchers did not attempt to further explore it.

Strengths of the study include the population covered by the databases being large and geographically diverse. Limitations include a lack of control of unexpected factors.

The FDA and the U.S. Centers for Disease Control and Prevention in January announced they detected a safety signal for ischemic stroke for people aged 65 or older, following receipt of Pfizer's bivalent vaccine. Ischemic stroke is a type of stroke caused by blood clotting.

In another preprint paper published on October 15, FDA researchers said they analysed Medicare data to estimate the risk of stroke after bivalent vaccination.

They included Medicare beneficiaries aged 65 or older who received a bivalent shot or an influenza vaccine and suffered stroke, except for stroke cases deemed to have been caused by something other than a covid shot.

The analysis showed an increased risk after Pfizer vaccination, for people aged 85 or older, of non-hemorrhagic stroke and for non-hemorrhagic stroke/transient ischemic attack. An increased risk was also

found for Moderna recipients aged 65 to 74 for non-hemorrhagic stroke/transient ischemic attack.

For people who received a Pfizer jab with an influenza shot, an elevated risk of non-hemorrhagic stroke was detected. For people who received a Moderna jab with an influenza shot, an elevated risk of transient ischemic attack was detected.

A separate analysis of only influenza vaccination detected an increased risk of non-hemorrhagic stroke following receipt of a high-dose/adjuvanted influenza shot, and signals for different ages.

The researchers with the FDA and Acumen said: "Our study did identify an elevated risk of stroke when the covid-19 bivalent vaccines were administered with a concomitant high-dose/adjuvanted influenza vaccine. However, the observed effects were not consistent."

A similar finding was detected in a study of data from the Centers for Disease Control and Prevention's Vaccine Safety Datalink system.

The researchers said the study's findings suggest the elevated risk of stroke in the group that received influenza and covid shots together 'was likely driven by influenza vaccination alone.'

How to stop 5G rollout

Tips for objecting to telecoms mast applications

TELECOMS giant Ericsson believes 'future networks will be a fundamental component to virtualise all parts of life, society, and industries, fulfilling the communication needs of humans as well as intelligent machines'.

So if you have been thinking that the current rollout in the UK of 5G is great, maybe that boast from Ericsson might make you think a little bit more.

This is just one of the reasons why I, along with many other people around the country, have been campaigning to stop this rollout until we have a general debate about it, especially concerning whether it will be harmful for people and the environment.

Let me give you another quote from the telecom companies themselves: 'The way 5G works, it is closely connected with the Smart City agenda.'

This is from a planning application from Clarke Telecom, from many planning applications in fact. So there really is an agenda. The question then becomes 'whose agenda?' Were we consulted? Did you know?

I am not going to write about all the reasons why we might not want this technology in our public domain; those have been written about elsewhere. What I am going to write about is one way that anybody can use to work against the continued imposition of masts on our streets, and radio frequencies spreading and beaming through the very atmosphere in which we walk, and into our homes.

This approach is through the planning system - the very same system that we have to use to build a house extension. This set of rules was changed in 2022, especially in the area of telecoms, but the government guidance on the changes still says 'all new masts will still require the prior approval of the local planning authority'. Of course this is not statute or law, but it is endorsed by two ministers of state.

Now let me cut straight to practical actions.

First of all, you will need to start looking at the planning portal on your own council's website. For most councils, it's relatively easy to get that far, and then the fun begins.

The planning portal is the only way

that you will learn when there is an application for a mast near you. That is why it is so important. Both the company and your council are supposed to do a proper consultation with local people, but they don't.

Anyone, anywhere in the country, can object or comment on any planning application, and, because it is an individual thing, everyone in a single household can make their own comments/objections.

Rule one in writing an objection is to avoid giving the '5G lecture'. It won't help; leave it for another day and another place. Stick to normal, everyday things, for example:

- It will increase the clutter in this city location, outside the supermarket, causing an obstruction for pedestrians, wheelchairs and prams.
- At this rural location, on a long straight street, it will appear as an obvious and alien feature on the landscape, changing the character of the area.

If you think those sorts of reasons are trivial, you're wrong, because they work in so many cases. Do note that the planning case officers are simply normal people like you and I; it's also highly unlikely that they have had any

extra training in planning for telecoms systems, and there are some unique factors in that.

For example, most structures or buildings they deal with will have no influence outside the land on which they stand. With a telecom mast, its whole purpose is to have an influence outside its footprint. Rarely is this factored into their decision.

Some of you will have heard of the Action Against 5G legal case. The last hearing for that was back in February, when about 70 of us attended the court to hear Michael Mansfield make the case for the complainants in front of Justice Stacey.

It was given only one-and-a-half days of court time, so the barristers had to be quite succinct. But when the judge's report arrived, it seemed there was very little resemblance to what had happened in court. The claimants decided to make another appeal, and are still waiting to hear if that will be granted.

On a slightly different approach, two other people have submitted a 'letter before action' about the failure of the government to embed the European Electronic Communication Code fully into UK law as part of the EU Withdrawal Act.

This is a slightly technical matter based around the use of the EEC which makes it mandatory for local authorities to

consider health concerns as material planning considerations - which they are not doing.

Although results are variable around the country, we are having many mast applications refused. If you want that to be in your town or city as well, the quickest way to start is to invite me to come to your group, explain the background, and show you how to navigate the system via the website of your own council.

Medicines can destroy health

Allergy claims used to disguise harmful effects

These treatments can cause the very problems they are claimed to be treating

IN our article published earlier this year entitled *Iatrogenesis: The Leading Cause of Death?* we discussed one aspect of the phenomenon known as iatrogenesis; namely that it is almost certainly the leading cause of death in most, if not all, countries.

Another equally important aspect of this phenomenon is that the medical establishment recognises that medicines produce harmful effects, but these effects are disguised by the use of different labels, the most common of which are: side-effects, allergies, adverse events, and toxicity through overdose.

The Allergy UK web page, Drug Allergy, explains under the heading, *What Is A Drug Allergy*, that: 'A drug allergy is the abnormal reaction of your immune system to a medication. Any medication - over-the-counter, prescription or herbal - is capable of inducing a drug allergy.'

The idea that a reaction by the body can be abnormal is disingenuous; the body never makes mistakes.

The description is qualified by the further comment on the web page that: 'A drug allergy is not the same as a drug side-effect, a known possible reaction listed on a drug label. A drug allergy is also different from drug toxicity caused by an overdose of medication.'

Interestingly, even the mainstream medical community is questioning the validity of the label 'allergy' with respect to reactions from the use of penicillin-based antibiotics.

According to a BBC article entitled *Millions Wrongly Labelled With Penicillin Allergy*, pharmacists warn, the Royal Pharmaceutical Society (RPS) is reported to have

said: 'Many people confuse antibiotic side-effects with an allergic reaction.'

But these labels, whether allergy, side-effect or anything else, belie the truth that medicines do not resolve health problems. Instead, they have been proven to be a significant causal factor for a wide variety of health problems.

The liver is known to be responsible for many different functions within the body, one of which involves detoxification. It is also said to be responsible for the metabolism of drugs. However, the metabolism of drugs also involves their removal from the body, which means that the body recognises them as toxic and therefore harmful, not beneficial.

The Mayo Clinic web page entitled *Toxic Hepatitis* lists many drugs that are hepatotoxic. They include over-the-counter pain relievers, such as paracetamol/acetaminophen, aspirin and

ibuprofen, as well as prescription medications such as statins, azathioprine and certain antivirals, such as tenofovir, which is used in the treatment of what is called hepatitis B infection.

It is obvious that liver disease is indicative of some form of liver damage - which may be given a label, such as hepatitis - that may then be treated with various drugs, some of which, tenofovir for example, are known to be hepatotoxic. In other words, these treatments can cause the very problem they are claimed to be treating.

It has been known for many decades that pharmaceutical drugs are capable of causing damage to the liver. This can be seen in a 1986 article entitled *The Spectrum of Hepatotoxicity Due to Drugs*, which states that: 'Drugs in common use can cause toxic effects on the liver which

can mimic almost every naturally occurring liver disease in man.'

The claim that the toxic effects of drugs mimic disease is disingenuous. Their inherently toxic nature means that drugs are the direct cause of damage to the liver, even if referred to as liver disease. This phenomenon is recognised by a 2010 article entitled *Drug-induced Liver Injury*, which states that: 'Drug-induced liver injury (DILI) is common and nearly all classes of medications can cause liver disease.'

Although paracetamol is the drug most commonly associated with liver damage, there are a number of different classes of medications known to damage the liver, including anesthetics, anticancer drugs, antibiotics, antituberculosis agents, antiretrovirals and cardiac medications.

Note that the majority of these products contain the prefix 'anti'.

One mechanism of action by which drugs can cause harm within the bodily organs is through the production of free radicals that induce oxidative stress, as indicated by a 2012 article entitled *Drug-Induced Oxidative Stress And Toxicity*.

It is abundantly obvious that the use of pharmaceutical drugs, whether prescription or over-the-counter, is increasing everywhere, but these products are not leading to improved health.

In fact, quite the opposite is occurring, as evidenced by statistics that show there is an ever-increasing incidence of all kinds of health problems.

This is particularly the case in countries where modern medicine is already practised and an increasing problem in countries where the World Health Organisation is trying to impose this system.

We appreciate that it may be difficult for some people to accept the idea that their medicines are more harmful than beneficial, but that does not make it untrue.

The reason that pharmaceutical drugs are not able to resolve health problems is explained by the late alternative medicine advocate, Herbert Shelton, in *Natural Hygiene: Man's Pristine Way of Life*: 'All drugs are physiologically incompatible with the functions of the body.'

Problems can only be solved by addressing the underlying cause.

Unfortunately, the medical establishment does not understand the true underlying causes of health problems, and so their solutions do not address them. There are of course consequences from applying incorrect solutions to a problem.

Herbert Shelton also described the consequences from the use of pharmaceuticals to manage symptoms: 'Physicians who are free with their drugging keep themselves busy treating the effects of the drugs.'

Exposing radiation risk

Sensitivity to electromagnetic waves ignored in health policies

REMEMBERING NEARFIELD is an internationally acclaimed short animated film that raises wider awareness about electrohypersensitivity (EHS).

This neglected disability is characterised by symptoms and functional impairments caused by exposure to man-made electromagnetic radiation (EMR).

Although the vast majority of the population is exposed to unprecedented levels of man-made EMR there are no common health policies in place regarding EHS.

This lack of support has long sustained societal disregard of EHS (also known as Microwave Syndrome).

Because EHS requires greater recognition, we need a conversation about the neglected health and human rights dimensions concerning EHS. My film brings these issues sharply into focus.

The absence of EHS from the public health conversation is deeply problematic. EMR pollution, (also called electrosmog) is a rapidly growing form of invisible environmental pollution with scientifically recognised impacts on the health of animals, plants and humans.

We are more sensitive than we think. Science recognises we are all electrochemical beings, with individual levels of sensitivity to man-made electromagnetic radiation.

Attempts at a one-size-fits-all solution for EMR exposure haven't succeeded. Scientists have found that so-called safe levels of EMR exposure can be damaging.

People with EHS can't tolerate the electrosmog emanating from electrical and wireless devices and infrastructure, and seek ways to reduce or eliminate from their environment. Scientists advocate reduction in EMFs, especially from nearfield exposures (more inductive exposures of EMFs closer to the body) to protect health. For people with EHS, this can eliminate symptoms that disrupt their lives.

EHS controversially challenges the blind

trust of society in current EMF exposure guidelines. Such guidelines are widely criticised for ignoring long-term exposure and crucial bioeffects data by prominent scientists such as James C. Lin.

Currently, EMF exposure guidelines formulated by organisations such as ICNIRP, IEEE, and the FCC reduce the health implications of EMF exposure to exclusively thermal impacts.

This has reduced society's expectations of any health impacts other than possible tissue heating.

But there is a bigger picture than microwave-induced temperature changes to be concerned about, hence international attention on the management of public health with appeals to governments (like the 5G Appeal aimed at the EU, United Nations and World Health Organisation).

There are ongoing legal cases as exemplified in the UK by Michael Mansfield QC challenging the government over its failure to acknowledge the wide health implications and public concerns about 5G and EMR.

The public is ready to listen about EHS. People seek answers to questions about EMR's potential influences on health. They are realising a lot of important things about EMR and health.



Remembering Nearfield is surprising many people, who previously knew nothing of EHS. This animated film is opening up the issues surrounding EMR health impacts, reaching people across the world; that's hugely important. Professor Olle Johansson, Neuroscientist and EHS expert, formerly of the Karolinska Institute, Sweden, said: "This film is in totality such a special work. It strikes such a deep chord in my soul. For an academic scientist like myself, it is always very impressive to see skilled movie makers, artists, and performers, summarise in less than ten minutes a staggering 45 years of research!"

Since April 2023 when it was released, it has won 12 international film festival awards and is nominated for more. At the Cannes World Film Festival in June, it won

Best Health Film.

Remembering Nearfield is built around the compelling testimony of Corriëlle van Vuuren, who narrates the film. She was diagnosed with EHS, and reflects upon her experiences, from being a successful entrepreneur to developing EHS, which brings familial breakdown, social exclusion and medical marginalisation. The realities of EHS remind us that no-one should be excluded from society because of the nature of their disability. The health and wellbeing of all are basic human rights to be valued and protected.

Do they want to be our gods?

IMAGINE you had ownership of practically all the world's money and resources, wealth beyond the dreams of kings and queens, conferring on you a sense of ultimate power and importance.

Having control over the contrived legal machinery lets you live above the law, which means you can do whatever you want with impunity. Total ownership of mainstream media, education, and science allows you to control the thoughts of the majority of the population, whose only purpose is to funnel ever more money and resources into your grasping hands.

With that intoxicating feeling of near-total power, where do you go next? How do you secure your status for ever? How do you shield yourself from the retribution of the downtrodden masses? How do you ensure that the seething slave class can never see their way to reclaiming what your 'master race' has stolen from them over millennia, thus cementing your rightful place as master of all the Earth?

There remains one last enemy; one final battle to win, which would ensure that you and your line can continue to lord over everything you survey in perpetuity. That enemy is hope, and hope is a potent force.

In *Man's Search for Meaning*, the psychologist and concentration camp survivor Viktor Frankl documented how the human spirit can prevail when all other power seems stripped away. He wrote: 'Forces beyond your control can take away everything you possess except one thing, your freedom to choose how you will respond to the situation.'

In the movie *The Hunger Games*, President Snow shares the reason why the authoritarian regime does not simply execute two dozen of the slave class each year to set an example to the rest: "Hope. It is the only thing stronger than fear. A little hope is effective. A lot of hope is dangerous. A spark is fine, as long as it's contained."

To achieve ultimate control, a tyrant must contain any Great Hope among the subdued, leaving them to cling onto small hopes, for temporary relief from pain and the numbing opiate of worldly comforts.

And what is the source of our Great Hope? It comes from the knowledge that each of us is part of something greater; that there is a purpose that guides all things in the service of righteousness, justice, beauty and truth.

Two months ago, my column *Thou Shalt Hate Nature* explored the idea that one

reason the 'powers that shouldn't be' seem to be trying desperately to turn us against nature is that it would leave us stranded, living in a godless world that came about by nothing more than random chance.

That's why they are trying to sever our connection with creation, and, from there, trust in any creator. If they can achieve that, perhaps their campaign for total control will be complete.

If they can break our trust in a creator, they can aspire to assume the status of gods on Earth. In the absence of ultimate authority, we must default to being governed by the laws of men and of scientific materialism.

Perhaps this is what Theodis of Megara was warning of when he wrote, in the sixth century before Christ:

'Hope is the only good god remaining among mankind; the others have left and gone to Olympus.

Trust, a mighty god has gone, Restraint has gone from men, and the Graces, my friend, have abandoned the earth.

Men's judicial oaths are no longer to be trusted, nor does anyone revere the immortal gods; the race of pious men has perished and men no longer recognise the rules of conduct or acts of piety.'

Do they want to make themselves our gods? Perhaps they think that, by removing God, they can claim power of life and death, as the Georgia Guidestones exhorted: 'Maintain humanity under 500,000,000 in perpetual balance with nature.' The implication, again, being that nature is faulty and needs man's interference.

Belief in a higher power beyond our

human knowing gives us purpose that supersedes life and death. It even gives people something to hope and live and die for. It points to forces for good that are more important than ourselves: profound, eternal values like truth, love, and justice.

Now, each individual's beliefs about the metaphysical realm are his or her own business. I don't care if you believe in a God or don't believe in a God. I don't even know if I believe in a God or how such a God might manifest. I do, however, believe, from the observation of my own senses, that the universe appears to act in God-like ways, and that's enough for me.

But here's something I do care about, regarding you and your belief system. Dogma aside, I believe that you are a spiritual warrior. I will bet that you believe in truth, love, and justice. Even if you do not consider yourself a spiritual warrior, I have faith that such a power lies within you and within each one of us.

That is what matters! That we hold firm to values that are greater than our own little lives. The service of life, in the realisation that our lives are both imperfect and perfect expressions of life itself.

And yet here we meet a paradox that sits right at the core of what it means to be human. Even if our discrete, short lives are part of a greater whole, we are also how that larger life manifests. Despite the controllers' attempts to distract us, we are nature, and nature is us!

Viktor Frankl also wrote:

'Each of us carries a unique spark of the divine, and each of us is also an inseparable part of the web of life.

'What matters, therefore, is not the meaning of life in general, but rather the specific meaning of a person's life at a given moment.'

If life matters, if creation has value, if experience of the divine means anything to us, it means that we too matter. And that, friend, gives us hope.

So perhaps their endgame depends on severing our connection with the divine, so that we will bow to them and call them gods. Perhaps, in a very real sense, they are in the business of stripping humanity of the part of us that still remembers where we belong. They really are harvesting our souls!

'For what shall it profit a man, if he shall gain the whole world, and lose his own soul? Or what shall a man give in exchange for his soul?' (Matthew 16:36-37)

They want ownership over our souls, perhaps in a very real, metaphysical sense. But, even figuratively, this mass culture is constantly exhorting us to sell out our deepest values in return for comfort and a little taste of wealth, status, celebrity, a taste of the VIP treatment. Life is short; only your ego matters; there is nothing beyond, nothing within. What you see is all there is. Grab a bit of it while you can.

'Because you're worth it!' (™ L'ORÉAL)

We have free will. We have the choice to worship wealth and fame; that is the whole point of being free-spirited beings. Or we can remember the commandment Moses brought down from the mountain: 'Thou shalt have no other God but me.'

Do you know what immediately precedes the verse 'What shall it profit a man...' in Matthew's gospel? These words: 'For whosoever will save his life shall lose it; but whosoever shall lose his life for my sake and the gospel's, the same shall save it.'

If there is no God, if this is all there is, then our ultimate treasure is that small, flickering light that burns for a few decades. So why not sell your soul? Why not chase the things of this world?

On the other hand, if we remember that we truly are part of an infinite love, then we might be ready to put aside our individual cares in the service of that higher power. Perhaps we might even be willing to give our lives in its service.

They know, if we are ready to give it all, we become very dangerous indeed. They know, if we are willing to sacrifice our egos for the greater good, they can't win.

'A delivery company has a total of 160 cars and vans, the number of cars compared to the number of vans = 3 : 5. Each car and each van uses electricity or diesel or petrol. 1/8 of the cars use electricity, 25% of the cars use diesel. The rest of the cars use petrol. Work out the number of cars that use petrol. You must show all your working'.

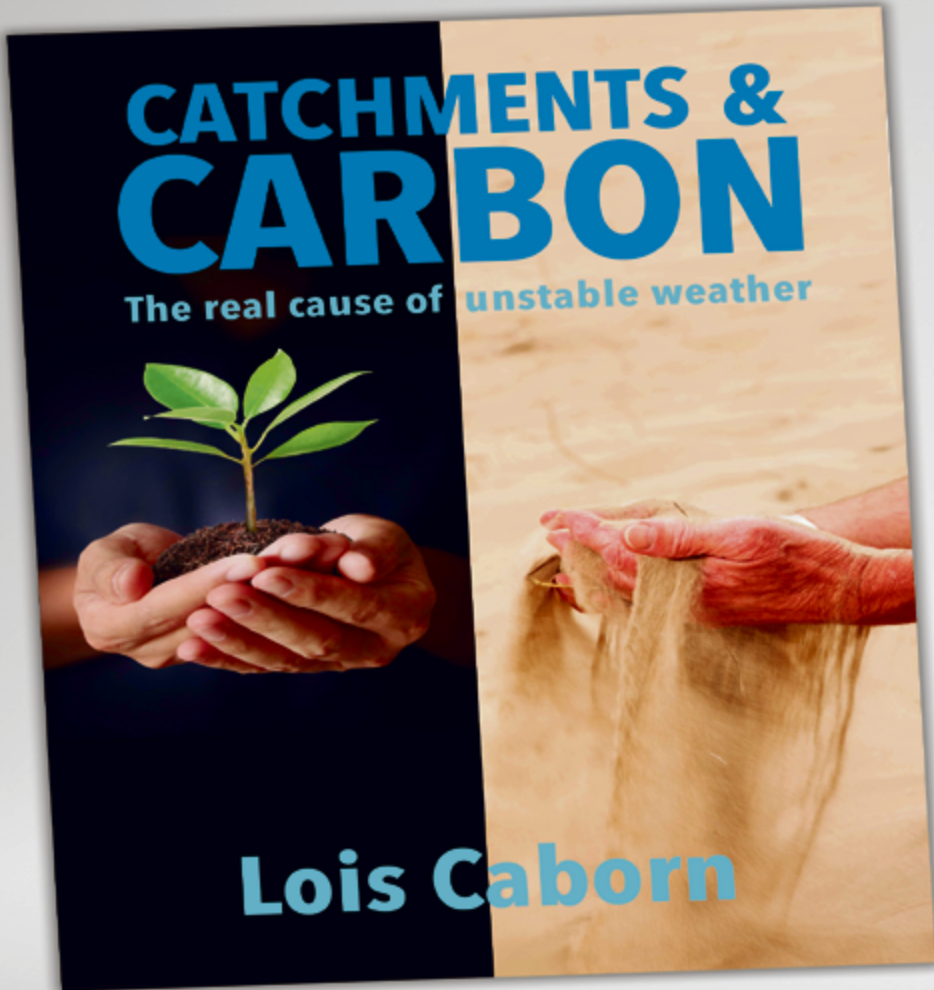

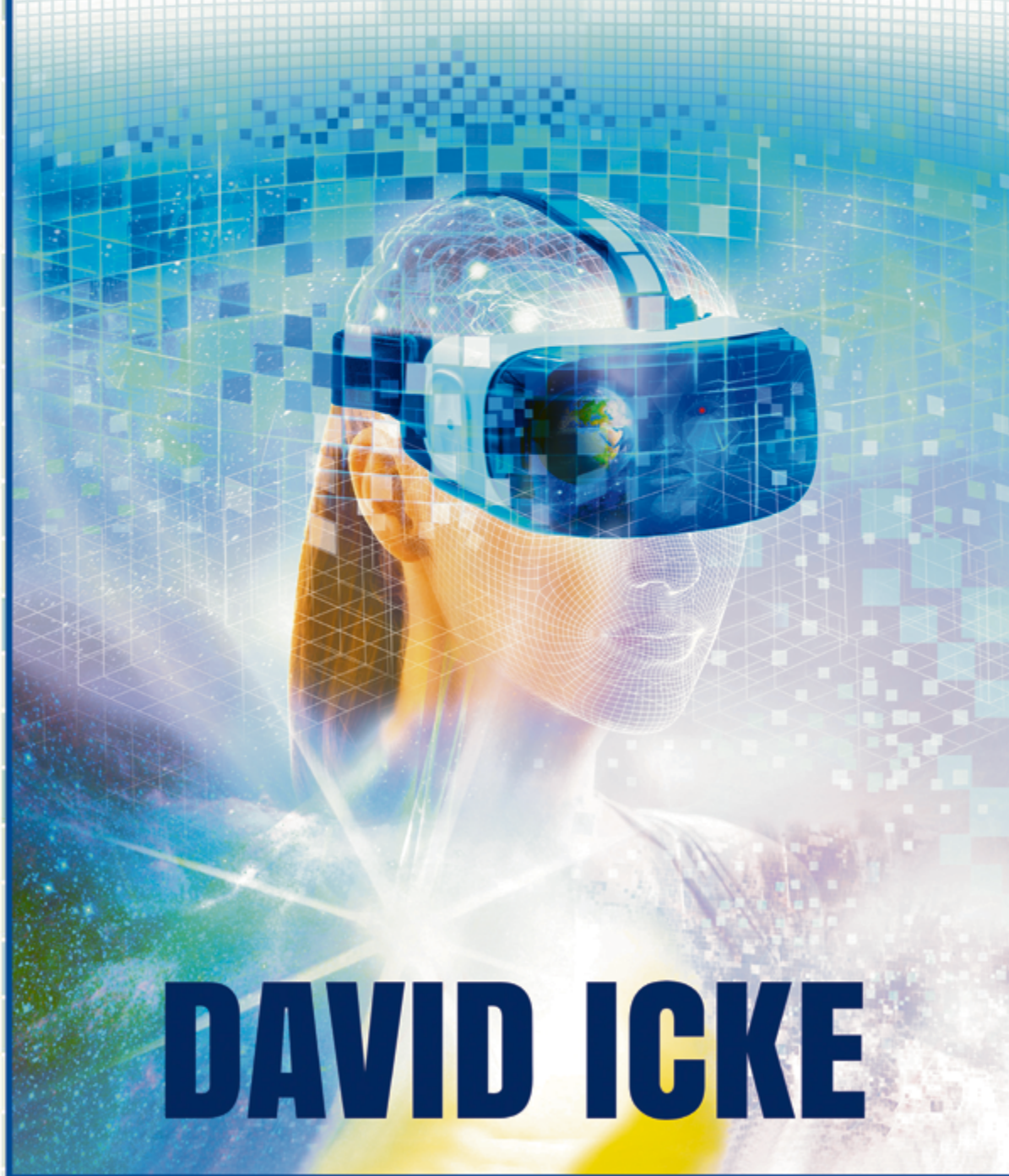

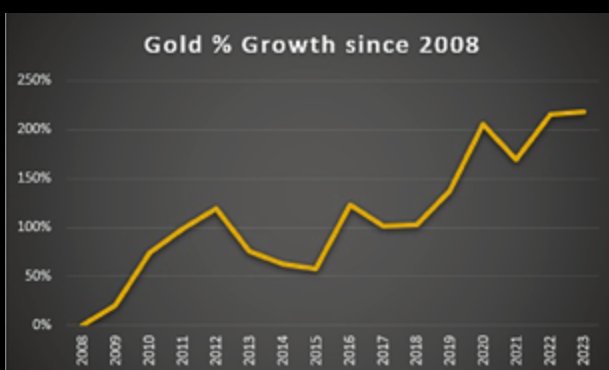
